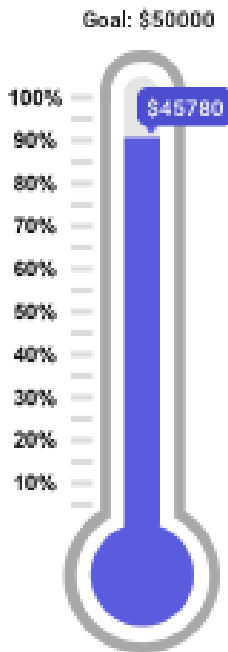

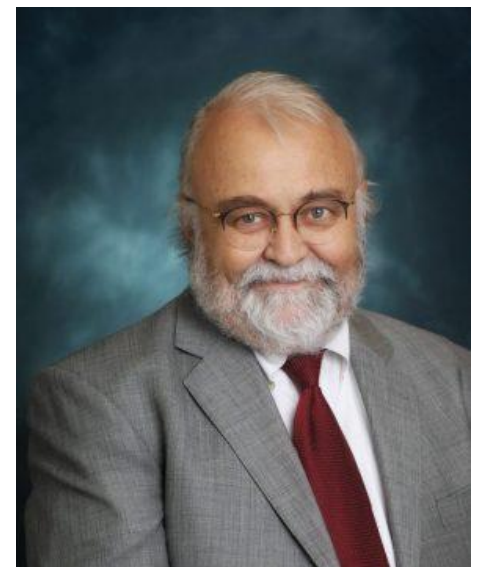

Volunteers Needed to Judge Speech, Interview and Essay Competitions

United States Academic Decathlon (USAD) is the premier national scholastic competition for high school students, created to provide opportunities for students to experience the challenges of rigorous team and individual competition. The theme for this year's competition is The Cold War.

High school students from Utah will compete virtually as they challenge themselves and others for state honors and the opportunity to compete at the national competition.

Volunteers are needed to assist with the competition. Be a part of the excitement! Meet students from around the state and watch them compete for team and individual honors. Feel their intensity and determination. We look forward to your participation and welcome your support.

When:

- Speech & Interview: Thursday, March 4, 4:00pm - 7:30pm (Optional Training: March 2, 3:00pm)
- Essay: March 1 - 3 (At your own pace, 2 -3 hour commitment)

Speech & Interview Competition:

Students will present prepared and impromptu speeches and complete interviews before a panel of judges via Zoom. Judges will submit scores online via a Google Form. Training will be provided on March 2nd at 3:00 pm via Zoom. Those unable to attend the training will be able to view the Zoom recording. If you have speech, public speaking, or interviewing skills, please consider volunteering as a judge in those areas.

Essay Competition:

Judges will read and score essays using their home computers and can expect to spend 2 -3 hours total between Monday evening March 1st, and Wednesday evening March 3rd. The essay judging will be completed at your own pace. Scores will be submitted online via the USAD website.
